S. R. O. No. 723/2016.—In exercise of the powers conferred by section 5 of the Cochin Christian Civil Marriage Act, 1095 (Act 5 of 1095), the Government of Kerala hereby appoint Sri T. Johnson, Sub Registrar, Kuzhalmandom, Palakkad District as the Marriage Registrar for the local area of jurisdiction in Palakkad (except the erstwhile Malabar area) and consequently make the following further amendment to the notification issued under G. O. (Rt.) No. 234/03/Law, dated 17th March, 2003 and published as S. R. O. No. 231/2003 in the Kerala Gazette Extraordinary No. 446 dated 17th March, 2003, namely:—

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per notification issued under G. O. (Rt.) No. 234/2003/Law dated 17th March, 2015 and published as S. R. O. No. 231/2003 in the Kerala Gazette Extraordinary No. 446 dated 17th March, 2003, as subsequently amended by notification published as S. R. O. No. 194/2015 in the Kerala Gazette Extraordinary No.754 dated 31st March, 2015, Government had appointed Sri T. Johnson, Sub Registrar, Vadakkanchery, Palakkad District as Marriage Registrar for the local area of jurisdiction in Palakkad (except the erstwhile Malabar area) under section 5 of the Cochin Christian Civil Marriage Act, 1095. As Sri T. Johnson, Sub Registrar, Vadakkanchery, Palakkad District has been transferred to Kuzhalmandom, Government have now decided to appoint Sri T. Johnson, Sub Registrar, Kuzhalmandom, Palakkad (except the erstwhile Malabar area) as the Marriage Registrar in the above said area and to make consequential amendment to the said notification.

The notification is intended to achieve the above object.
