Whereas, the Hon'ble Supreme Court of India, in its judgment dated 14/02/2006 in Seema Vs Ashwinikumar (2006 (1) KLT 791 SC) has directed all State Governments to issue Rules for making registration of marriage solemnized in the respective

States compulsory irrespective of the religion. As per the direction, State Government published the Kerala Registration of Marriages (Common) Rules,2008, as G.O.(P)1/2008/Law dated 29/02/2008 (Link )and till this date made the following amendments.
